

CONTAINER & PACKAGING REQUIREMENTS FOR REGULATED SHIPMENTS

If you are shipping two (2) or less batteries and eight (8) or less cells packing requirements Nos. 1-4 below apply. Use strong outer packaging appropriate for weight of contents (i.e. box must be rated for the maximum weight being placed in the box) If you cannot tell the weight rating of the

- Verify that all batteries are packed for ZERO contact with other items contained with batteries packed with equipment. They must be either completely wrapped in packaging (cannot contact other items) OR+and-terminals taped with <u>ELECTRICAL</u> tape.
- Add the marking to the box that states "LITHIUM BATTERIES FORBIDDEN FOR TRANSPORT ABOARD AIRCRAFT AND VESSEL".

If you are packing 3 or more batteries AND/OR more than 8 cells, you must follow packing requirements No. 3 above AND Nos. 5-10 below.

- 5 Use a UN Certified Box as shown. 4G/Y25/S/2#USA/+CO2384
- 6 Apply Class 9 lithium ion battery label
- Add a cargo aircraft only marking to the box.
- Add proper shipping name to box. UN3090, Lithium Cells or Batteries.
- Address label is mandatory. The receiver (TO/Consignor) address and the shipper address (FROM/Consignee) must be on the box. Listing the quantity of batteries in the container on package is optional.

Add an overpack marking if the battery or battery cell is contained in another box or on a pallet underneath shrink-wrap AND place markings listed in No. 6, 7, 8 and 9 above also on the outer box or shrink wrap.

Ground shipping: ALLOWED | NO AIR OR VESSEL SHIPPING IS PERMITTED W/O WRITTEN AUTHORIZATION FROM LIIHAZMAT@LENNOXINTL.COM. IF WRITTEN AUTHORIZATION IS GIVEN, LIMITS ARE:

Passenger aircraft/rail: FORBIDDEN | Cargo aircraft: ALLOWED-77 lb (35 kg) limit | Vessel: ALLOWED- Stowage Category A
