

# Packing Instruction | CA-3481-CIE

PSN: UN3481, Lithium ion batteries contained in equipment

STEP 1: ARE YOU PACKING ANY OF THESE TYPES OF PRODUCTS? IF YES, THIS PACKING INSTRUCTION APPLIES.



### FOLLOW STEPS 1-3 BELOW IF YOUR SHIPMENT MEETS ANY OF THE FOLLOWING:

- 1) If you are packing in a small means of containment less than 450L water capacity OR
- 2) You are shipping five (5) or less boxes of batteries/cells and each box weighs 30kg or less OR
- 3) The total gross mass of your dangerous goods shipment is 500 kg or less and included in that shipment is no more than five (5) boxes containing batteries/cells weighing 30 kg or less.

### **CONTAINER & PACKAGING REQUIREMENTS FOR SMALLER SHIPMENTS**

- Use strong outer packaging appropriate for weight of contents (i.e. box must be rated for the maximum weight being placed in the box AND WITHSTAND A DROP FROM 1.2 METERS). If you cannot tell the weight rating of the box, please ask your supervisor and/or contact Lennox Environmental at liihazmat@lennoxintl.com or +1-972-497-7532.
- Apply the UN3481 marking shown to the each container (e.g. box or other outer packaging). Be sure to include a contact number on the marking where people with questions can call about the shipment.
- 3 Shipping paper is always required that shows contents of box or other outer packaging)

- 6 Add a cargo aircraft only marking to the box.
- Add proper shipping name to box. UN3481, LITHIUM ION BATTERIES CONTAINED IN EQUIPMENT.
- Address label is mandatory. Listing the quantity of batteries in container on exterior is optional.

Add an overpack marking if the battery or battery cell is contained in another box or on a pallet underneath shrink-wrap AND place markings listed in No. 6, 7, 8 and 9 above also on the outer box or shrink wrap.
